2022 Price Guide for Services

USA Investigative Agency is a licensed and insured investigations, security, and training firm established in 2022 and operating in Florida. Investigations Division:

Complimentary Confidential Consultation: Up to 30-minute call at no cost. **Please prepare for your 30 min call so our team can best meet your needs,** we will use this call to determine our recommendations and tailor your investigative services.

Comprehensive Background Search: This search is a full report that includes properties, vehicles, family members and associates, criminal history, social media names, all addresses, etc. This report would be estimated at One Hundred and Twenty-five dollars (\$125) per report. ****Flat-fee searches will require signed agreement and be billed, and invoice must be paid prior to results being released.**

Extensive Background Search: This service is customized for each client.

Civil Process Service: To serve the subpoena, we encourage to first try the local authorities. If their efforts fail, then give us a call. We consider the budget and then look at how difficult the service might be. Each service is different. Past fees have ranged from \$100 to \$500 and beyond depending on the level of difficulty.

Standard Investigation: Billed at one hundred dollars (\$100) per hour for one licensed and experienced private investigator. The case could be civil or criminal in nature.

Physical Surveillance: Billed at Ninety dollars (\$90) per hour for the lead private investigator. The lead investigator will run the operation, gather relevant facts, assemble the team of investigators, collect and compile evidence from the team, upload evidence to a digital case file, and complete detailed reports. Assisting investigators will be billed at Sixty dollars (\$60) per hour, per investigator. Minimum team size for physical surveillance is two (2), and USA Investigative Agency has authority to add investigators based on the operation. There will be a four (4) hour minimum for each requested day of surveillance.

Remote Camera Surveillance: Billed at Two Thousand dollars (\$2,000) for twenty (20) investigative hours where a high definition camera with remote transmission capability is deployed on/at the target location or desired area. After the collection period, which may be weeks, the camera(s) will be recovered, and data reviewed. All data will be stored, and pertinent data placed in the client's digital case file. Remote camera surveillance cases can be customized per the client's request. All state and federal laws will apply to this type of surveillance.

GPS Surveillance: This service is customized for each client. Same as above, all state and federal laws will apply to this type of surveillance. Keep in mind there are only a few instances where a GPS tracker can be applied legally.

Same Day Service: Billed at One hundred and Fifty dollars (\$150) per hour for the lead investigator and One-Hundred dollars (\$100) per hour for assisting investigators. Rates can be negotiable based on the case or operation.

Stand-By Basis: Billed at Five hundred dollars (\$500) per day, per investigator. If client demands results that require investigators to be on "stand-by" for immediate action.

Holidays: Billed at Two hundred dollars (\$200) per hour for the lead investigator and One-hundred and fifty dollars (\$150) per hour for assisting investigators.

Expert Testimony: Billed at Two hundred and Fifty dollars (\$250) per hour. This service can be complex, and a face-to-face meeting will be arranged with the Client and Expert prior to the court proceeding.

Every case is unique, and all investigative requests can be customized to fit your needs.

MOST cases (excluding flat-fee searches) require a minimum non-refundable deposit of one thousand five-hundred dollars (\$1,500.00) to be paid accompanied by an electronic agreement to be executed PRIOR to any investigative actions being taken.

Security Division:

Armed Officer Services: The rate, on average, per armed professional officer can range from Forty-Five dollars (\$45) to Sixty dollars (\$60.00) per hour. USA Investigative Agency Officers are active or retired law enforcement officers and/or military personnel.
